
Transit Worker Assault Data

- Rates of operator assaults and other major security events have increased since 2010
- Rates of injuries and fatalities due to all major security events have also increased
- Average annual percentage increase:

Operator assaults	+18%
All other assaults	+20%
Personal security events	+17%

Data Source: National Transit Database, 3/3/22 Includes all major security events (including burglary, larceny, theft, and robbery). Excludes suicides.

Bipartisan Infrastructure Law

FTA published a Dear Colleague Letter on February 17, 2022 to set deadlines for Bipartisan Infrastructure Law Public Transportation Agency Safety compliance (PTASP) requirements. The Bipartisan Infrastructure Law requirements include:

- Engaging frontline workers in Agency Safety Plan development and the agency's SMS
 - Includes requirements for a Safety Committee, for some agencies
- Requirement for de-escalation training
- Risk reduction program to reduce worker assaults that includes safety performance targets
- Safety set-aside

The Bipartisan Infrastructure Law also requires transit agencies to report data on assaults on transit workers to the National Transit Database (NTD)

• FTA is revising NTD reporting requirements to reflect this requirement

Overview

Enhanced Transit Safety and Crime Prevention Initiative: Federal Funding

Section 5307 and 5311 funding

- Planning and capital expenses to prevent operator and passenger assaults
- Purchase of vehicles with security features such as operator shields
- Public transportation safety and security operating assistance projects (for urbanized areas with population of less than 200,000 and 5311 recipients)

Section 5337 State of Good Repair Grants

- Projects to maintain security equipment and systems in a state of good repair
- Projects must be included in the Transit Asset Management Plan

Section 5339 Grants for Buses and Bus Facilities

- Capital funding to purchase buses, bus facilities, and bus-related equipment
- Includes operator compartment shields and other equipment to improve worker safety


Enhanced Transit Safety and Crime Prevention Initiative: Federal Funding

<u>COVID-19 supplemental funding and supplemental</u> <u>COVID-19 funds for security operating expenses</u>

- Operating expenses and activities that improve safety and security
- Capital expenses for safety and security projects (*if requirements related to furloughs are met*)

FTA safety research programs

- Safety Research and Demonstration Program
- Public Transportation COVID-19 Research Demonstration Grant Program
