## Q & A Highlights

### Question 1:

What type of data should we include in our hazard identification and risk assessment log?

#### FTA Response:

FTA does not prescribe what transit agencies should record in hazard identification and risk assessment logs. The PTASP regulation requires agencies to maintain documentation related to the implementation of their SMS for three years, including results from SMS processes and activities. However, FTA does not stipulate the methods of documentation ([49 CFR § 673.31](#)).

Transit agencies may choose to use or tailor one of the sample safety risk registers provided by FTA to support their agency's hazard tracking. This is an information management tool agencies can voluntarily use to document their Safety Risk Management and Safety Assurance activities.

Examples of data and information a transit agency may want to record in such tools include:

- Identified hazards and the potential consequences associated with these hazards;
- Existing related mitigations your agency may have in place;
- Initial safety risk ratings of the potential consequences;
- New mitigations your agency has implemented to eliminate or minimize the risk associated with the consequences of the hazards;
- Revised safety risk ratings; and
- Mitigation monitoring measures and activities to ensure mitigation implementation and effectiveness.

### Question 2:

Could a rail transit agency's (RTA) State Safety Oversight Agency (SSOA) have requirements for a safety risk register or hazard log?

#### FTA Response:

Yes, under the authority of the State Safety Oversight (SSO) program, an SSOA may choose to require that each RTA under its jurisdiction use a safety risk register or hazard log. This requirement would be spelled out in the SSOA's Program Standard. For example, an SSOA

may require that its agencies use a safety risk register to document the results of Safety Risk Management and Safety Assurance activities.
