FY22 COVID-19 Spot Reviews – Round 2 Results

- As of 11/8/22, 20 Spot Reviews have a total of 33 deficiencies
 - ECHO Procedures 19
 - Eligibility of Expenses 12
 - Financial Management Systems 2

- 14 State DOTs receiving reviews in Round 2
 - As of 11/8/22, 3 State DOTs have 4 deficiencies
 - ECHO Procedures 2
 - Eligibility of Expenses 2

What is the Oversight Tracking System (OTrak)?

- FTA's official system of record for program oversight data.
 - Ex: State Management Reviews (SMRs)
- Launch/Rollout:
 - Launched for FTA staff and contractors April 26, 2021
 - Federal Fiscal Year (FY) 2023 Recipient Pilot Program planned
 - Sub-set of Triennial Review (TR) and State Management Review (SMR) recipients
 - Full recipient use expected for Federal FY 2024 review cycle
