
# **Safety Communication and Best Practices**

FTA's outreach efforts promote understanding and acceptance of safety initiatives, safety authority, rule requirements and compliance deadlines.

FTA practices two-way communications with workers, riders and the Industry

 GovDelivery email distribution, social media, monthly e-newsletter, website with safety topic webpages, conference participation, webinars, workshops, trade publication articles and regular meetings with stakeholder groups.

# **Public Transportation Agency Safety Plans**

- Requires certain operators of public transportation systems that receive FTA funds to develop Agency Safety Plans that incorporate Safety Management System (SMS) principles and practices.
- The regulation applies to more than 700 transit agencies and 50 States.



# **Bipartisan Infrastructure Law and PTASP**

The Bipartisan Infrastructure Law added new PTASP requirements:

#### Agencies receiving 5307 funds and serving Large UZAs:

- Establish safety committees with equal numbers of frontline employee representatives and management representatives
- Establish risk reduction programs and targets, and set aside 0.75% of section 5307 funds for safety related projects
- Increase safety training: include maintenance personnel in the agency's comprehensive safety staff training program and provide de-escalation training
- ✓ Address strategies consistent with the CDC or State health authority guidelines to minimize exposure to infectious diseases

#### Agencies serving Small UZAs:

- Develop an Agency Safety Plan (ASP) in cooperation with frontline employee representatives
- Address strategies consistent with the CDC or State health authority guidelines to minimize exposure to infectious diseases

# **Bipartisan Infrastructure Law Requirements: National Public Transportation Safety Plan (NSP)**

Guides the national effort to manage safety risk in the nation's public transportation systems following the principles of SMS. The Bipartisan Infrastructure Law added new NSP requirements:

 ✓ Establish safety performance measures by mode to address new risk reduction program requirements.

✓ Update voluntary safety standards.

✓ Include precautionary and reactive actions required to ensure public and personnel safety and health during an emergency.

# **Bipartisan Infrastructure Law Requirements: Transit Worker Assault**

**Bipartisan Infrastructure Law** 

Expands information collected on transit worker assaults


> Engages frontline employee representatives in Agency Safety Plan development and SMS (including Safety Committee for certain agencies)

Requires certain agencies to create a Risk Reduction Program

Reduce number and rates of accidents, injuries, assaults on transit workers

Establish Safety Performance Targets (SPTs)

### **State of Rail Transit Safety**





# **Taking Action to Reduce Transit Worker Assaults**

From 2008-2021, transit agencies reported an average of 241 worker assault events per year

- 192 per year occurring in or on transit vehicles
- 44 per year occurring in transit revenue facilities
- Five per year occurring in non-public locations, such as maintenance shops and yards



# This data includes only the most serious events, and may significantly underestimate the total number of assaults



# **Taking Action to Reduce Transit Worker Assaults**

# Special Directives: Required Actions Regarding Transit Worker Assault

- Issued to nine agencies that reported 79% of assaults on transit workers to NTD between 2016-2021
- Confirm that named recipients are addressing transit worker assault risk using their SMS processes (as required by the PTASP regulation and noted in the subsequent operator assault Federal Register notice)
- Determine if additional FTA intervention is required to reduce transit worker assault likelihood and/or severity in advance of pending regulatory action and subsequent risk reduction program development

  - Violence in the Transit Workplace






#### Overview

# FTA Safety Advisory 22-4: Suicide Prevention Signage on Public Transit

### **Overview**

Published: December 7, 2022

Audience: Transit Agencies

Purpose:

- FTA encourages transit agencies to implement, update, or expand suicide prevention signage and messaging campaigns that apply best practices for reducing suicide attempts.
- Additionally, FTA encourages incorporating general mental health awareness on public-facing media, partnering with suicide prevention organizations and assessing suicide event and crisis center data through Safety Risk Management and Safety Assurance processes.





# FTA Safety Advisory 22-4 Takeaways

Suicide is the leading cause of fatalities on transit

Suicide has an emotional and psychological impact on everyone the event impacts: family, friends, transit workers, transit leadership, and the community

Research suggests that suicide prevention signage is an intervention that can save lives

Transit agencies should consider installing or updating existing suicide prevention signage along operating routes in highly visible areas



# **Suicide's Impact on Agency Operations**

### **Impact to Operations**

- Suicide on transit impacts everyone involved, including transit operators
- In addition to impacts on operator well-being, suicide events may impact transit agencies' daily operations
- These impacts may include:
  - Missed work hours to recover from the shock, which is especially relevant in times of employee shortages and understaffing
  - Time to complete required station maintenance after an event
  - Difficulty in recruiting and maintaining workforce

# Suicide Prevention Signage on Public Transit

### Signage

- Display the national Suicide & Crisis Lifeline phone number (988) and the local crisis center or local public transit helpline phone number
- Direct patrons to nearby public phones, if available
- Present information in all languages frequently spoken within the jurisdiction
- Consider language, word choice, and other demographic risk factors, like age and gender, within the jurisdiction for signage and messaging campaigns






