## **Purpose of FTA Oversight**

- Ensure awarded federal funds are properly used for public transportation
- Confirm and promote recipient compliance with program requirements
- Provide technical assistance to correct identified deficiencies
- Help address Congressional and public questions about the use of federal funds



### **Enhanced Review Focus Areas**


- May be requested by FTA in any of the 23 review areas
- Involves additional questions and documentation
- Completed by a Subject Matter Expert (SME)

## **Triennial Review Steps**

- Recipient Information Request (RIR)
- Contractor review of RIR responses
- Site visit agenda and follow-up questions
- Site visit in person or virtual
- Preliminary list of deficiencies
- Draft and final reports
- Corrective action implementation

### **The Contractors Manual**

- A comprehensive guide to the Triennial and State Management Reviews
- Includes EVERY question that will be asked during the review
- Updated annually
- Includes a summary of changes at the beginning of the manual

#### The Contractors Manual – Format

- Purpose of the review area
- Questions to be examined
- Information needed from the recipient
- Questions
- Issues/areas of concern for FTA awareness
- References
- Useful weblinks



## The Contractors Manual – Question Format

- Review Area question
- Basic requirement
- Applicability
- Detailed explanation for reviewer
- Flexibilities and administrative relief (if applicable)
- Indicators of compliance
- Instructions for reviewer
- Potential deficiency determinations
- Governing directives



## **Preparing for the Review**

- Document, document!
- Download the new Contractors Manual every year and note changes
- Hold Mock Reviews
- Examine single audit or internal audit findings
- Participate in peer-to-peer reviews
- Attend FTA workshops and webinars

## **Improving Compliance**

#### **Pre-Review:**

- Use the regional office and other recipients as technical resources
- Train staff in requirements
- Monitor changes and adjust processes accordingly

#### **Post-Review:**

- Implement corrective actions
- Submit documentation to FTA regional office BY THE DUE DATE
