**Please note:** The Q&A Highlights below, as well as the [PTASP Frequently Asked Questions](#), pertain to the [PTASP Final Rule](#) that is currently in effect as of July 19, 2019, and the Bipartisan Infrastructure Law [statutory requirements in 49 U.S.C. 5329\(d\)](#). However, they do not pertain to the PTASP [Notice of Proposed Rulemaking](#) published April 26, 2023 in the *Federal Register*.

## Q & A Highlights

### Question 1:

Our CSO has a direct line of reporting up through the operations function to a Vice President, who reports to the Chief Operations Officer. The CSO also has a dotted line, for PTASP purposes, directly to the Chief Executive Officer, who serves as the Accountable Executive.

Does the PTASP regulation require that the CSO report directly to the Accountable Executive?

### FTA Response:

The PTASP regulation requires that the CSO have a direct line of reporting to the [Accountable Executive](#) without intermediaries.

If a transit agency places a CSO position under a manager other than the Accountable Executive, it must ensure the CSO can report and communicate safety issues directly to the Accountable Executive. Some transit agencies use a dotted line on their organizational chart to indicate that the CSO has authority to speak with the Accountable Executive at any time about safety matters, even if another employee supervises the CSO.

### Question 2:

Our agency has two ASPs: one for our bus modes and one for our rail modes. Can we have two Safety Committees?

### FTA Response:

Yes. A transit agency operating under two ASPs for bus and rail may establish one Safety Committee for each ASP, so long as both committees comply with the [Bipartisan Infrastructure Law changes to PTASP requirements](#).
