New! Prevention of Alcohol Misuse and Prohibited Drug Use in Transit Operations: FTA published a notice in the Federal Register to announce the calendar year 2024 drug and alcohol random testing rates for specific recipients of FTA financial assistance. The minimum random drug testing rate will remain at 50 percent and the random alcohol testing rate will remain at 10 percent.

### State Safety Oversight (SSO) NPRM

On November 15, 2023, FTA published an NPRM in the <u>Federal</u> <u>Register</u> (Docket No. FTA-2023-0008) proposing revisions to the SSO regulation to implement new requirements of the Bipartisan Infrastructure Law (enacted as the Infrastructure Investment and Jobs Act (IIJA)), remove outdated references, and simplify notification requirements. <u>Submit comments</u> on the proposed changes by February 15, 2024.

# **PTASP TAC Update** December 2023

Please note: The Q&A Highlights below, as well as the PTASP Frequently Asked Questions, pertain to the PTASP Final Rule in effect as of July 19, 2019, and the Bipartisan Infrastructure Law statutory requirements in 49 U.S.C. 5329(d). They do not pertain to the PTASP Notice of Proposed Rulemaking published April 26, 2023 in the Federal Register.

# Q & A Highlights

#### **Question:**

What are the PTASP safety training requirements for a transit agency's employees and contractors?

#### **FTA Response:**

The PTASP regulation at 49 CFR § 673.29(a) requires transit agencies to establish and implement a comprehensive safety training program for all agency employees and contractors directly responsible for safety in the agency's public transportation system. The program must include refresher training, as necessary. Under the Bipartisan Infrastructure Law, transit agencies that receive Section 5307 funding and serve an urbanized area with a population of 200,000 or more (large urbanized area) must ensure that their training program includes maintenance personnel and deescalation training. Given the different sizes of transit operators and the varying operating environments of systems across the nation, the PTASP regulation gives each transit agency flexibility to determine the level of training that is adequate for its comprehensive safety training program.

In addition, the Public Transportation Safety Certification Training Program (PTSCTP) regulation (49 CFR Part 672) sets forth Federal requirements for the certification and training of State Safety Oversight Agency (SSOA) personnel and contractors who conduct safety audits and examinations of rail fixed guideway

## Transit Worker Hours of Service and Fatigue Risk Management Advance **Notice of Proposed Rulemaking** (ANPRM)

On October 30, 2023, FTA published an ANPRM on Transit Worker Hours of Service and Fatigue Risk Management in the Federal Register (Docket No. FTA-2023-0018). FTA seeks information on these two topics to better understand current industry practices, priorities, requirements, and the costs and benefits of Federal requirements. Submit comments on hours of service and fatigue risk management programs by January 29, 2024.

### **Proposed General Directive 24-1: Required Actions Regarding Assaults** on Transit Workers

On December 20, 2023, FTA published a proposed General Directive on Required Actions Regarding Assaults on Transit Workers in the Federal Register (Docket No. FTA-2023-0032).

Submit comments on the proposed general directive by February 20, 2024.

public transportation systems (RFGPTS) and a transit agency's designated personnel and contractors who are directly responsible for safety oversight of an RFGPTS. Each recipient that operates an RFGPTS must designate its personnel and contractors who are directly responsible for safety oversight and ensure they are enrolled in the PTSCTP and complete the safety training curriculum within three years of their initial designation (§ 672.13(a) and (c)).
