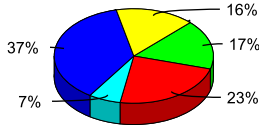

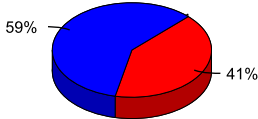

Sources of Capital Funds Expended

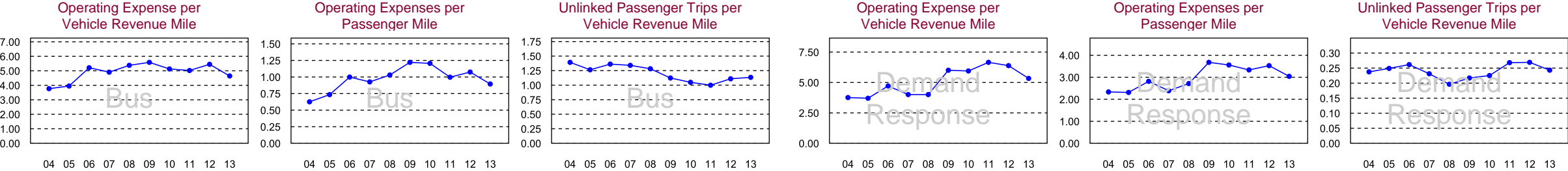
