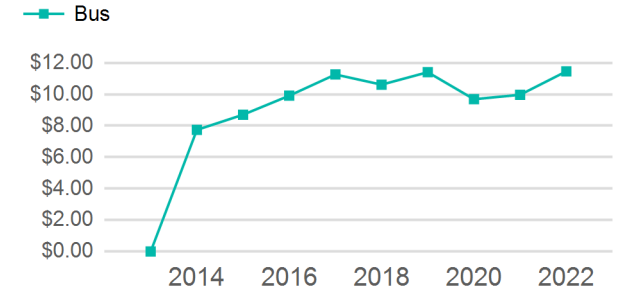

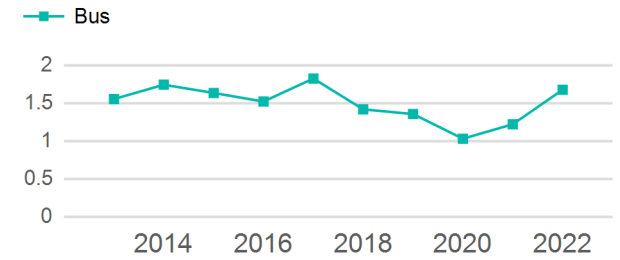

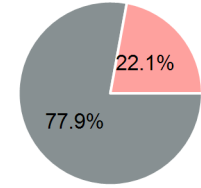

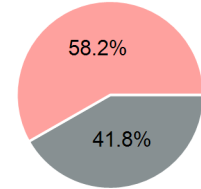
Operating Funding Sources
