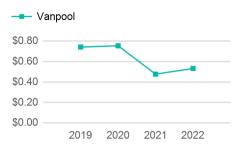

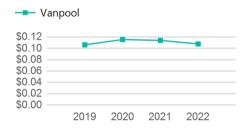

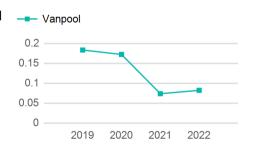
#### enses per Vehicle nue Mile
