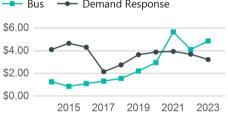

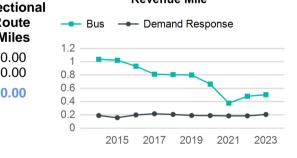
**Operating Expenses per Vehicle**
